3. Scope

4. Policy Statement

locations on campus, reflecting the institution's commitment to national values and regulatory compliance.

- The UAE flag must be flown at all times in designated areas of the campus, properly maintained, and replaced if damaged or worn.
- Official portraits of UAE leaders should be displayed in key administrative areas, reception spaces, and other approved locations.
- All displays must be in line with the UAE's official guidelines, ensuring uniformity and adherence to national directives.

6. Maintenance and Upkeep

- Flags and portraits should be regularly inspected to ensure they remain in pristine condition.
- Any damaged or faded national symbols must be replaced immediately.
- Staff members responsible for campus operations must oversee the implementation of this policy.

- Any will full disrespect or mishandling of national symbols will be addressed through appropriate disciplinary measures.
